#### **TERMS AND CONDITIONS:-**

1. The EMD of Rs.25,000/- by D.D should be submitted along with Tender from drawn from any Nationalized Bank drawn in favour of “**Medical Superintendent & Deputy Chairman, KSDNEB, Bengaluru.**”
2. The un-sealed Tenders, incomplete tenders and tender received after the due date are liable for rejection.
3. The rate should be quoted per Ton/ Kg.
4. Accepted Tenderer is required to execute an agreement on a stamp paper of the value of Rs.200/-.
5. The Materials are kept open for inspection at Karnataka State Diploma in Nursing Examination Board, Bengaluru 1<sup>st</sup> Floor Library Block, Bangalore Medical College & Research Institute campus, Bangalore-02 during working hours from 10.00 A.M to 4.30 P.M. on all working days.
6. The successful Tenderer will have to lift the materials at his own cost within 5 days from the date of work order.
7. The Valued Examination answer scripts, with wrappers and other records are of “**Confidential in Nature**” connected with the public examinations, as such these items cannot be sold in the open market. Therefore, the successful Tenderer is required to pulp or cut these items into halves either vertically or horizontally before disposal and a certificate to that effect should be recorded on the bill. Violation of this condition will amount to breach of trust and will be liable for legal proceedings.
8. Accepted rates cannot be altered during the currency period of the Tender Agreement.
9. If the successful Tenderer fails to remove the stock within the stipulated period the EMD will be forfeited. The same will be re-tendered again. Loss of amount if any incurred in this connection will be recovered from the defaulter.

10. **The successful Bidder should deposit an amount of Rs.1,00,000/- on receipt of the confirmation order from the Paramedical Board, Bangalore. And before remove the stock from the board, you should settle the final balance amount on online payment. Tenderer received after the last date will not be considered.**
11. The Tenderer should agree to pay all statutory taxes.
12. EMD of un-successful bidders will be refunded after finalization of tenders.
13. The EMD amount will be refunded, only after satisfactory completion of the work. No interest will be paid on this amount.
